#### 1. IDENTITY AND CONTACT DETAILS

#### 3. DATA SHARING

## 8. COOKIES

To make our websites (and indeed most websites) work properly, we sometimes place small data files called cookies on your device. A cookie is a small text file that a website saves on your computer or mobile device when you visit the site. It enables the website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time, so you don't have to keep re-entering them whenever you come back to the site or browse from one page to another.
